# Description

Synthetic rubber adhesive, suitable for multipurpose applications for interior and exterior use. It can be used in bonding PVC, rubber, leather, cork, wood, laminated plastic, etc. It is not recommended for bonding polystyrene.

# Instructions for Use

## **SURFACE PREPARATION**

The surfaces to be bonded must be dry and free from dust and dirt.

### **APPLICATION**

Thinning/Cleaning: Thinner 11/11 (Peletico's product). Thinning is not recommended.

Application tools: Roller or Brush.

**Application Temperature:** Ideal temperature for the application should be between 5-35°C and the relative humidity should not exceed 80%.

Stir well before application. Apply evenly on both surfaces. Leave surfaces to dry for 10-15 minutes. For better results, press firmly using a rubber mallet, or a heavy cylinder or any other suitable tool. During the first 48 hours the bonded surfaces should not be subjected to high temperatures.

**Cleaning of Tools:** Tools must be cleaned immediately after use with **Thinner 11/11** (Peletico's product).

PACKING: 0.25L, 0.5L, 1L and 4L.

**COLOUR:** Beige hue.

**STORAGE:** Store in a dry place, away from direct sunlight and/or extreme temperatures. Close the container after application.
