Instructions for Use

SURFACE PREPARATION

Remove all surface contamination, e.g. dust, oil stains and dampness by washing with an appropriate cleaner, rinse thoroughly and allow to dry. Peeling or cracked paint should be scraped off and sanded to a sound surface. Metal surfaces should be clean from rust and old paint and then coated with the appropriate metal primer (Grey/Red Oxide Metal Primer). Moisture content of wood must not exceed 20%. Surfaces previously painted with Alkyd or water based enamels should be sanded dull. Areas of bare wood or metal should be coated with the appropriate primer, before **ProMar® 200 UNDERCOAT** application.

APPLICATION

Thinning/Cleaning: De-ionised water.

Application tools: Brush, Roller or Airless spray.

Application Temperature: Ideal temperature for the application should be between 5-35°C and the relative humidity should not exceed 80%.

Stir well before use. Apply one coat of **ProMar® 200 UNDERCOAT** and then sand and clean the surface.

Cleaning of Tools: Remove as much paint as possible from tools and clean immediately with water and detergent solution.

COLOUR RANGE: Please refer to Sherwin-Williams® fan deck.

STORAGE: Store in a dry place, away from direct sunlight and/or extreme temperatures. Close the container after application.
